### **EPAL** pallet exchange procedure

The following is an explanation of how to manage the exchange of EPAL pallets (hereinafter referred to as 'pallet(s)').

### Immediate exchange with daily validity 'EPAL Voucher'

When the supplier or a company designed by the same (the 'Carrier') delivers the goods on EPAL pallets to the Esselunga Distribution Centre ('Ce.Di.') warehouses located in:

- **Limito**, via Giambologna, 1 20096 Pioltello (MI);
- **Biandrate**, SP Biandrate Recetto, 580 28061 Biandrate (NO);
- **Chiari**, Via Sam Quilleri, 1 25032 Chiari (BS);
- **Sesto Fiorentino**, Via Tevere, 3/5 Loc. Osmannoro 50019 Sesto Fiorentino (FI);

(hereinafter referred to as 'Ambient Warehouses'),

Esselunga will issue a paper EPAL voucher (the 'EPAL Voucher') at the end of the collection process, which will expire on the same day as it is issued.

The daily deadline allows the Carrier to collect the number of <u>suitable</u> pallets on the Voucher, on the same day of delivery, <u>from the 'Empties Department' in Ambient Warehouses</u>, thus facilitating immediate exchange.

Please note that the number of pallets exchanged will be affected by <u>any</u> that are <u>deemed unsuitable for exchange</u> (due to breakages or substandard quality).

The EPAL Voucher also permits postponed collection of pallets within 90 (ninety) days from the date of its issue.

#### Postponed exchange with 90-day validity 'Voucher'

#### In case of:

- total/partial unavailability of pallets at Ce.Di. (also due to seasonal peaks);
- request by the Carrier not to collect the pallets due to lack of space on the vehicle or in the case of very tight delivery times;
- delivery of goods by the Carrier at the 'satellite' Ambient Warehouses located in:
- Liscate, via Papa Giovanni XXIII, 6 20050 Liscate (MI) Ce.Di. Limito
- **Prato**, Via Lione, 12/1 59100 Prato (PO) Ce.Di. Sesto Fiorentino

and at the Fruits&Vegetables, Dairies, Cold Cuts Fresh Warehouses ('Fresh Warehouses') located in:

- **Limito (Fruits&Vegetables)**, via Giambologna, 1 20096 Pioltello (MI);
- Limito (Dairies & Cold Cuts), via Pordenone, 2 20096 Pioltello (MI);
- **Biandrate**, SP Biandrate Recetto, 580 28061 Biandrate (NO);
- Chiari, Via Sam Quilleri, 1 25032 Chiari (BS);
- Campi Bisenzio, Via delle Cicogne, 7 50013 Campi Bisenzio (FI).

Esselunga will issue a voucher (the 'Voucher'), valid for the postponed collection from the Empties Department in the Ambient Warehouses of a number of pallets equal to the number of suitable pallets not directly exchanged, and with a validity



of 90 (ninety) days from the date of issue of the Voucher (according to expiry date indicated on it).

Please note that the number of pallets exchanged will be affected by <u>any</u> that are <u>deemed unsuitable for exchange</u> (due to breakages or substandard quality).

To arrange the date and time of collection of the pallets, it is necessary for the Supplier and/or Carrier to send a written request to Esselunga to the following email addresses (enclosing a copy of the vouchers in their possession):

It is specified that for the effective collection of the pallets, the Carrier must be in possession of valid and original vouchers sent in advance by e-mail (even if in the meantime - while waiting for the date of the appointment - the 90-day period of validity has expired).

It is understood that once the 90 (ninety) day period indicated on the Voucher has expired, it will no longer be possible to collect the pallets.
